As outlined in the Consultancy agreement my outreach activities in February 2009 were centered upon fair housing and community advocates and the diverse public/private membership of the Sonoma County Housing Coalition. By continuing on-going contacts and networking the 2150 College Creek concept has been introduced to a number of prospective for profit and non-profit partnering organizations. In addition resources for eventual neighborhood outreach efforts are being identified.

## Our 2/24/09 SCWA meeting identified next steps as follows:

- Agency will begin work on 2150 College Ave. RFP to declare land as surplus and pursue either long term lease or land trust for property.
- Consultant will contact and brief Supervisors Zane and Carrillo regarding "College Creek" and request their participation on an RFP evaluation committee. The Criteria for evaluation will be established by the committee with the help of SCWA staff, Consultant, and County Counsel.
- Community outreach and identification of possible private and public partners to continue as an ongoing activity.
- Consultant will continue outreach to all constituencies identified in the Consultancy agreement to ensure the progress of implementation of a redevelopment plan for the West College property.
- Submission of a scope of work proposal for continued services by Consultant.

In March Consultant will meet with City of Santa Rosa to ensure that the Housing element and necessary General Plan Amendment is proceeding satisfactorily. As of this date 2/27/09 all progress appears to be on track for an eventual General Plan Update by late spring or early summer 2009 adoption by the Santa Rosa City Council.

Shirlee & Efren-- Randy Poole is asking me to set up a meeting to discuss this workforce housing neighborhood initiative that we have been working on for the past three years. The SCWA will be moving forward to the Board of Supervisors with a Request for Proposal in the near future, and we would love to have the 5<sup>th</sup> and 3<sup>rd</sup> District Supervisors on the evaluation committee. The evaluation committee would most probably include an affordable housing advocate, architect, and other community leaders that we could enlist to evaluate the proposals. The committee should probably have seven or nine members.

As part of my consultancy contract with the Water Agency I was responsible for bringing forth a site plan for 2150 College. In addition as value added Hart Marin produced a business plan, de we saved the County about \$150,000. by having the College Creek site included for study in the City of Santa Rosa updated Housing element plan. Due to present economic conditions the preferred alternative identified in the business plan is Alternative A which is all rental, and will produce an annual income of close to \$500,000.00 net after expenses.

We hope to use cutting edge green building practices, solar energy, and water conservation measures. In addition we are hopeful to enlist the Labor Unions to provide apprenticeship opportunities for future green jobs. We plan to document this project as a reproducible template for future public/private partnerships both here, and nationwide.
